Summary of ISO 9001:2008

- The quality system is regularly audited and evaluated for conformance and effectiveness.
- Records show how and where raw materials and products were processed, to allow products and problems to be traced to the source.
- The business determines customer requirements.
- The business has created systems for communicating with customers about product information, inquiries, contracts, orders, feedback and complaints.
- When developing new products, the business plans the stages of development, with appropriate testing at each stage. It tests and documents whether the product meets design requirements, regulatory requirements and user needs.

The letters "CE" are the abbreviation of French phrase "Conformité Européene" which literately means "European Conformity". The term initially used was "EC Mark" and it was officially replaced by "CE Marking" in the Directive 93/68/EEC in 1993. "CE Marking" is now used in all EU official documents.

1. CE Marking on a product is a manufacturer's declaration that the product complies with the essential requirements of the relevant European health, safety and environmental protection legislations, in practice by many of the so-called Product Directives.\*
2. CE Marking on a product indicates to governmental officials that the product may be legally placed on the market in their country.
3. CE Marking on a product ensures the free movement of the product within the EFTA & European Union (EU) single market (total 30 countries)
4. CE Marking on a product permits the withdrawal of the non-conforming products by customs and enforcement/vigilance authorities.
